Glenn FleischerAug 31, 1924 ~ Aug 31, 2020

Glenn Fleischer served honorably and proudly as a 1st Lt in the Army Air Corps during WWII. He was 96 years old. He was predeceased by his wife of 74 years, Frances Burns Fleischer who passed on Mar. 28, 2020. Glenn served in the 494th Fighter Squadron of the Ninth Air Force of the US Army Air Corps piloting a P-47 Thunderbolt. In 1946, he was shot down near the Rhine River, south of Cologne and was a POW.
